Mandate

- Develop, implement and oversee SSO's governance and compliance program
- Review the status of SSO's compliance with applicable laws and regulations
- Review the status of SSO's compliance with its By-laws and board policies
- Review each of SSO's By-laws and board policies at least every three years and recommend changes, as required



Ontario Sport Recognition Policy

- Sets out mandatory requirements that all PSO/MSOs must meet in order to be recognized by the Government of Ontario
 - Ensures PSO/MSOs meet high standards in governance, administration and programming
 - Positions Ontario as best-in-class PSO/MSO jurisdiction



Sport Recognition Policy (cont'd)

- Launched June 2016
- PSO/MSOs must apply for recognition
- Recognition status is a prerequisite to apply for Ministry funding



Overview of Approach

- Mandatory requirements
 - Administration / Governance
 - Not-for-profit, elected board of directors, by-laws, operational & financial policies, multi-year strategic plan and annual operational plan, budget & financial review engagement report / audit, insurance, annual general meetings, etc.
 - Policies
 - Approved by board of directors and posted on website



Mandatory Policies

- The following are mandatory policies under the Sport Recognition Policy:
 - Code of conduct for directors, coaches, officials, athletes & parents
 - Discipline
 - Dispute resolution
 - Harassment
 - Concussion management & return to play
 - Membership
 - Selection to provincial team
 - Privacy
 - Accessibility
 - Inclusion (by April 1, 2018)
 - Screening (by April 1, 2018)
 - Confidentiality (by April 1, 2018)
 - Social media (by April 1, 2018)
 - Anti-doping (by April 1, 2018)



Sport Recognition

- SSO application for Sport Recognition submitted October 2016
 - Application viewed by Ministry as "extremely thorough and comprehensive"
 - SSO granted Ontario Sport Recognition effective April 1, 2017
 - As a recognized sport, SSO was allowed to apply for Ontario Amateur Sport Fund (OASF) grant
 - Consolidates former Base Funding Program, Sport Priority Fund and Team Ontario Development Grant
 - SSO OASF grant application submitted May 2017
 - Notice of funding decisions anticipated by early July

- These documents were developed in collaboration with OSSC coach Laura Steacy and her colleagues at the University of Toronto Concussion Lab



Activities since March 2017

- Participation in the Enhancing Sport-specific Concussion Policies Project Team
 - Hosted by Ontario Physical & Health Education
 Association (OPHEA) and the Coaches Association of Ontario (CAC)
 - Goal is to enhance sport-specific concussion management policies / protocols
 - Ruth Belcher & Laura Steacy participated in multisport policy enhancement session, April 2017
 - Next phase of project is Expert Team review



Activities since March 2017 (cont'd)

- Online Injury Report form
 - In collaboration with the Sunnybrook Office for Injury Prevention
 - SSO has customized Sunnybrook's Play Safe Injury
 Tracker, a web-enabled surveillance platform for sport injury
 - Generates reports, including at club level
 - Helps SSO and clubs better monitor, respond and prevent injuries, including concussion injuries
 - Fully supported by SSO's insurance provider
 - For release by no later than September 2017
