DIRECTOR ELIGIBILITY:

Please refer to section 4.02 of the OAS Bylaws, which is available here.

To be eligible for election as a Director, an individual must:

- a) Be eighteen (18) years of age or older.
- b) Not have been found under the Substitute Decisions Act, 1992 or under the Mental Health Act to be incapable of managing property.
- c) Have the power under law to contract.
- d) Have not been declared incapable by a court in Canada or in another country;
- e) Not have the status of bankrupt.
- f) Not be a person not in Good Standing with OAS or any other sport organization.
- g) Be a "resident" of Ontario as that term is defined in the Income Tax Act (Canada).
- h) Not hold any employment, or contractor positions with CAS, any other CAS Member, or with the Corporation or its Members.

The OAS board may only have one (1) Director affiliated with a Member club at one time. Affiliation includes being employed by, or engaged in activities with, a club including as a director, officer, committee member, coach, manager, athlete family member, or other individual registered with the club. For clarity, if the OAS board has a current Director who is affiliated with a Member club, an individual who is also affiliated with that same club would not be permitted to stand for election.
