We launched a modern registration system that eliminates the need for Member Clubs to track and maintain physical waivers. Children's participation in sport waivers have no statute of limitations and must be stored indefinitely. These waivers are now maintained electronically by OAS, ensuring a more efficient, secure, and convenient registration process for everyone involved while also ensuring compliance with the highest regulatory standards. This innovation marks our commitment to simplifying administrative tasks, enabling clubs to focus more on nurturing talent and promoting the sport.



Exiting the shadow of COVID-19, we have had the pleasure of hosting and participating in some fantastic events this season. Our teams and athletes have demonstrated remarkable resilience and adaptability, showcasing their skills and artistry at various levels of competition. Further details about these events will be provided within our report, underscoring the dedication and hard work involved in ensuring the success of these events.

Thanks to the dedication of our coaches, athletes, and support staff, the HP program has continued to see significant growth and improvement. With a continued focus on providing world-class training environment and support system, our athletes continue to achieve outstanding results and push the boundaries of what is possible in artistic swimming.





# **FINANCIAL REPORT**

As we reflect on the past year, it becomes evident that our dedication to fiscal responsibility and strategic investment has enabled us to overcome challenges, seize opportunities, and advance our mission.

#### **COVID-19 Relief Funding**

In these unprecedented times, the global COVID-19 pandemic posed significant hurdles for sports organizations everywhere. However, I am pleased to report that Ontario Artistic Swimming successfully navigated these challenges and, with the unwavering support of our provincial government, we were able to secure \$462,000 in COVID-19 relief funding. This funding was earmarked for distribution among our member clubs to aid in their sport development efforts. Through a rigorous and inclusive selection process, we ensured that all 20 member clubs had the opportunity to apply for and receive much-needed relief.

#### **Strategic Investments**

In addition to supporting our member clubs, OAS made strategic investments in several key areas. We modernized our operations with the acquisition of a new scoring system, an investment totaling \$25,000, aimed at enhancing the overall experience for our athletes, officials, and fans.

To further bolster our financial sustainability, we made the prudent decision to move to a more compact office space, aligning our resources with our operational needs. This move not only enhances our efficiency but also underscores our commitment to responsible resource management.

#### **Programming & Marketing Initiatives**

In recognition of the importance of promoting our sport and engaging our community, we significantly increased our marketing efforts. These investments have borne fruit by raising the profile of our organization and creating opportunities for growth.

OAS also continued its commitment to Safe Sport, partnering with independent third party, Brian Ward, to ensure our sport remains a safe and welcoming environment for all participants. Additionally, we introduced the Support Zone, an initiative dedicated to promptly addressing inquiries and concerns related to sport-related issues.



As a testament to our resilience, we proudly hosted our first in-person conference since the onset of the COVID-19 pandemic. This gathering brought together officials, club presidents, and coaches, providing a platform for collaboration, learning, and growth.



Thank you for your unwavering support, and here's to another year of achieving great heights in the world of sports.






# **FINANCIAL STATISTICS**

# HUMAN RESOURCES REPORT

The Mandate of the Human Resource Committee is to assist the Board in fulfilling its obligations relating to human resource matters through the review and recommendation of sound compensation, making recommendations regarding HR policies and practices that reflect legislative requirements and best practices and helping to maintain a healthy workplace culture within the Ontario Artistic Swimming organization.

This season marked the first full season since the onset of the COVID-19 pandemic. This season was, however, far from normal with the implementation of the new World Aquatics rules resulting in an overhaul of the scoring system, impacting all aspects of our sport.

As the rule transition required much time and effort, no changes to the committee structure were made in this fiscal year. # **RISK MANAGEMENT REPORT**

# HIGH PERFORMANCE REPORT

The 2022-2023 season featured several high performance highlights.

#### **Provincial Teams**

Summer of 2022 marked the return of the Provincial Team program following COVID. Three teams were selected (11-12, 13-15 and Junior) and trained at Toronto Pan Am Sports Centre before traveling to Edmonton for the 2022 SYNC Invitational in July. This was also the first year that CAS designated the SYNC Invitational event as the selection event for the Youth National Team. Team Ontario dominated at SYNC, winning gold in every event except Junior Free Duet, where Ontario athletes brought home the silver medal.

By virtue of the 13-15 team's win at SYNC 2022, the team was selected to represent Canada at the 2022 FINA Youth World Championships August 10-14 in Charlotte, North Carolina. Team Ontario did Canada proud with strong performances and 4th place finishes in team and solo. The highlight of that event was the bronze medal in duet won by Olena Verbinska and Abby Wang.



#### **Athlete Programs**

2021-2022 saw the return to in person sport development seasons. The objective of the programs was to provide identified athletes and their coaches with enhanced training and programming that will help them to develop the necessary foundation and skills to be successful in one day representing Ontario Artistic Swimming and Canada Artistic Swimming on the international stage.

FutureGEN!, L2T & T2T participated in virtual and in person sessions that included Drama, Stroke and Skill Development, Flexibility and included a session that iallowed the athletes to interactive with CAS and OAS officials.

In February 2022, OAS held a one day technical workshop for the L2T and T2T athletes with special guest experts Kasia Kulesza CAS NextGen Head Coach and Yingli Hou CAS Junior National Team Assistant Coach.



#### **Coach Programs**

The Coach UP! program offered expert-led coach development workshops & webinars Integrated with high performance programming. Sessions included how to write a YTP, Flexibility, Drama and Posture and Alignment and an age-appropriate training exercise module used to improve physical performance. As well coaches had on deck access to the November CAS HP Camp including an interactive session in November with Kasia Kulesza CAS NextGen Head Coach.





#### **HP Academy**

In October, the OHPSI-partnered OAS HP Academy Program resumed with a kickoff weekend in Toronto. This program provides in-pool and dryland activities to support the development of identified athletes on the high performance pathway, through a combination of centralized and regional sessions. The kick-off weekend featured technical sessions with the new 2022-23 OAS HP Provincial Coaches: Lola Shnayder Mazour, Julia Thornton and Brooke Whitney. In addition, athletes worked with CSIO experts in the areas of physical testing, strength and conditioning, and mental performance skills. Guest expert Jose Guerra, a National level diving coach, assessed all of the Academy athletes for acro flyer potential and provided guidance to the HP Provincial Coaches on training flyers.

#### **CAS Development Camps**

In Fall of 2022, CAS held their Development Camps across the country for the second year in a row. In November, Ontario hosted a joint CAS Development Camp and Technical Conference. The Development Camp was open to our HP Academy athletes, and the Technical Conference welcomed coaches and officials from across the province. Led by Kara Heald, the conference focused on educating coaches and officials on the new World Aquatics scoring and judging system, through a combination of classroom and on-deck sessions.

In the pool, Academy athletes engaged in technical skill sessions with Next Gen Head Coach Kasia Kulesza, Junior National Team Assistant Coach Yingli Hou, and Canadian Olympians Rosalie Boissonneault and Camille Fiola-Dion. Athletes also performed some of the new quad's figures and elements for the judges attending the conference and received scores for their height out of the water.

#### **Regional Technical Sessions**

In December, athletes participated in regional technical sessions led by the three HP Provincial Coaches. Judges from each region provided feedback to athletes on figures and technical elements, while the Expert Coaches led athletes through drills targeting important skills. The HP Academy Program finished with an in-person pool session following the Leslie Taylor Ontario Cup, which featured Canadian Olympian Andree-Anne Cote sharing the story of her Olympic journey, and a dryland session with CSIO experts following the National Qualifier.

# ADAPTED COMMITTEE REPORT

The Ontario Adapted Artistic Swimming Committee was launched in the Fall of 2022. This groundbreaking committee was formed to address the needs of our fast-growing Adapted artistic swimming category (formerly known as Athletes with a Disability). Members represent various stakeholders within the Adapted category: athletes, coaches, officials and parents.

The OAdASC met monthly during the 2022-23 season. Notable contributions for 2022-23 are:

- Change of the name of the category from AWD to Adapted artistic swimming.
- Update of the Adapted figure groups so that the skills build consecutively from level to level. This update improves both the athlete experience as they progress more logically through the levels and the competition flow and judge experience at figure competitions.
- Through a partnership with Natation Artistique Quebec, led the National alignment of Adapted figures.
- Creation of a new position for hosted Ontario events: the Accessibility Coordinator. This volunteer position acts as a liaison between the organizing committee and the Adapted artistic swimming community to ensure that Ontario events are accessible for all.
- Submission of recommendations to CAS for rules and qualifying procedures for Adapted athletes at National events

The OAdASC would like to thank the artistic swimming community for their passion and dedication to the growth and evolution of the Adapted category, as we strive to continually improve our sport and ensure it is welcoming and inclusive for all.

### **COMMITTEE HIGHLIGHTS & KEY INITIATIVES**

#### Try Art Swim Campaign Redesign and Promotional Content Development

In early 2023, OAS engaged Chinook (full service web/marketing agency), to redevelop what is now our annual "Try Art Swim" digital acquisition campaign. The campaign, scheduled to launch across OAS social media channels in Fall 2023, will support and empower clubs by providing a campaign cross-promotion kit and materials that will be available on OAS' website for individual club-use and marketing support.

In addition to redesigning the "Try Art Swim" campaign, the Committee also worked with videographers and photographers throughout 2022-2023 to diversify existing content libraries and develop promotional content to be utilized in the 2023-2024 season and beyond.

#### **Event Management and Support**

Throughout the year, OAS staff and committee members led or supported communications activities for more than 15 events including OAS and CAS skills assessment events, competitions with live-streaming, Annual Meeting and Journey to Excellence Conference, webinars and workshops, bi-weekly online and phone club update calls, and others.

The Committee and staff also supported the administration, coordination, promotion, and execution of a number of competitions in addition to its recurring competitive season, including Ontario Winter Games and SYNC 2023.

In advance of the transition to a new scoring system provincially, OAS provided multiple learning and feedback opportunities to coaches through workshops, demonstrations, documents/packages, and other. These opportunities worked to prepare Ontario clubs for the 2023-2024 season, and support National level athletes throughout the 2022-2023 season.

In addition to OAS-led events, the team engaged with our provincial, national and international partners in hosting the 2023 National Qualifier and supported the 2023 Artistic Swimming World Cup in Markham, Ontario. During these events, staff and committee members worked to create opportunities for provincial athlete and club involvement including volunteering roles, medal presentations, and event promotion.





#### **Social Media and Digital Engagement**

The Committee and OAS staff developed and executed micro social media campaigns and initiatives in support of key provincial, national, and sport-related days of recognition, as well as membership and sport profiling initiatives including National Coaches Week, National Volunteer Week, CAS and OAS competitions and camps, World Aquatics competitions, High Performance programming, and OAS Provincial Team programming.

The team worked strategically to highlight and engage with club social media content to increase overall exposure and collaboration between PSO and member clubs.

#### **Issues Management**

The team continued to maintain OAS' website, making significant updates to OAS' Policies and Safe Sport webpages, member portal, and resources. We organized and/ or facilitated webinars and workshops to improve education and awareness of safe sport practices, and supported OAS issues management activities as needed.

### **COMPETITIONS, RULES & TECHNICAL COMMITTEE**

The OCRTC was newly formed for 2022-2023 to replace and update the Rules Committee. This committee met regularly throughout the season and is composed of both coaches and officials in an effort to provide balanced perspectives to lead Ontario's technical recommendations.

The biggest challenge faced by the OCRTC in 2022-23 was the fusion of the old and new rules and judging systems at Ontario events. This required a great deal of flexibility and innovative thinking in order to make athlete-centred decisions that aligned with National rules and kept competitions flowing smoothly.

Another major initiative for the committee in 2022-23 was to begin the long overdue process of updating the OAS Rulebook. An Ontario Addendum to the CAS Rulebook was created to streamline the document and reduce confusion. This Addendum outlines any deviations from the CAS Rules that are implemented in Ontario.

The OCRTC received numerous rule change requests for next season which are under review. Thank you to the committee members for volunteering their time and energy, and to the broader OAS community for your passion and ideas to improve our competitions structure to better serve our athletes.

### ONTARIO OFFICIALS COMMITTEE REPORT

The Ontario Officials Committee has had a productive and busy year, including a full slate of provincial Competitive and Regional League events, as well as additional hosted competitions including Ontario Winter Games, the CAS National Qualifier, and SYNC.

In addition to the 12 OAS-hosted events, Ontario played a significant role in making history as it supported the Artistic Swimming World Cup in Markham. This international competition, hosted by Canada Artistic Swimming, was the first to implement the new Artistic Swimming scoring system. Many of our provincial officials, committee members, and OAS staff were integral to the success of this competition by supporting a number of volunteer roles.

#### 2022-2023 Competitive Season

Within Ontario, our Officials participated in Virtual Dryland Testing, in-person competitive meets, and selection for our HP programming which resulted in Ontario Athletes travelling to the PanAm Age Group Championships in Fort Lauderdale, Florida, and the Youth Worlds Championships in Athens, Greece.



The demand on Officials remains high with Ontario being one of the largest Artistic Swimming communities in Canada. The dedication of the Officials within Ontario to continually provide consistent judging at every meet is commendable.

#### **New Scoring System Preparation**

In preparation of the new scoring system being fully implemented in Ontario next season, provincial officials were some of the first in Canada to attend meets using the scoring system including at our National events and at SYNC 2023.

In order to be able to deliver the new scoring system at our competitions next season, the OOC worked together with OAS staff to facilitate training for new Difficulty Technical Controllers and Synchronization Technical Controllers. Throughout the season, Technical Controllers and practice TC's were able to practice live at four separate events in collaboration with OAS staff and coaches who had submitted unofficial coach cards for each event.

We were extremely pleased to see almost 30 candidates take the Technical Controller course and practice throughout the season. Ontario was also able to certify many Practice Judges and provide ongoing mentoring at competitions and practice opportunities to educate new Level 1 judges in our sport.

As a committee, the OOC would like to thank all the many coaches, officials and volunteers who have contributed much over the course of this past season. We remain committed to providing our athletes with many opportunities to compete as well as being a resource for our coaches within Ontario.

Many thanks to each and every Official who has contributed in the past year. Your volunteerism is very much appreciated.
